The Legalities of Libations

The alcoholic beverages industries, including the production and distribution of craft beer, wine and distilled spirits, are thriving and growing even bigger in North Carolina. As of 2021, the state is home to more than 350 craft breweries alone, ranking the state 9th in the nation with an estimated economic impact of nearly \$2 billion. The wine industry has a similar economic impact (June 2021). Distilleries in the state are also seeing unprecedented growth.

However, as with most growth, the rise of the state's alcohol industry also brings with it challenges. Alcohol producers, distributors and retailers must comply with federal, state and local permitting requirements and other laws while navigating the myriad other legal issues.
